Confidentiality Agreement

Attendance of the 2018 Idx24 Workshop implies acceptance of the following Terms and Conditions.

1. Definitions

Idx24 is a mechanical rule based trading methodology. Idx24 consists of nine strategies which collectively are referred to as Idx24. The nine strategies include IAD, IAM, IAS, IAR, IAB, IDXB, IDXE, IDXR and IDXW. The Attendee is the person named below who seeks to obtain Idx24 by attending the 2018 Idx24 Workshop ("Workshop") and who is the subject of this Confidentiality Agreement ("Agreement"). The Vendor is Brent Penfold, the author and copyright holder of Idx24.

2. Non Disclosure of Confidential Information

Idx24 includes information that remains the intellectual property of the Vendor. The Vendor claims and retains all rights to Idx24 and the information it contains.

The Attendee acknowledges it is against the Vendor's interests for Idx24 secrets to be disclosed. The Attendee acknowledges disclosure and piracy of Idx24 proprietary information would disadvantage the Vendor and contribute to loss of income. The Attendee acknowledges it would also be against their own interest if Idx24 secrets were disclosed and reduce the value of their investment in attending the Workshop.

The Attendee agrees not to disclose any of the information to any other party in any manner or form. The Attendee agrees that any such disclosure will damage the value of Idx24 to the Attendee and to others and deprive the Vendor of income and will be liable for those losses.

3. Not For Resale

Upon ceasing to use Idx24 the Attendee is prohibited from reselling Idx24 to a third party. The Attendee undertakes to return or destroy Idx24 and any copies thereof upon ceasing to use Idx24.

4. Not To Be Used For Managing Third Party Funds

The Attendee agrees that Idx24 is supplied for the sole use of the Attendee to manage their own money and not money belonging to third parties such as (including but not restricted to) investment companies, investment unit or discretionary trusts, investment clubs or institutional type funds etc. which are not for the direct benefit of the Attendee and their direct family.

5. Non-Refundable

The Attendee agrees that due to the nature of the information contained in Idx24, no refund will be granted under any circumstances or conditions.

6. Indemnity

The Vendor, its officers, employees, representatives and agents expressly advise that they shall not be liable in any way for any loss or damage, whether direct or indirect, consequential or otherwise howsoever arising, whether in negligence or otherwise out of or in connection with the contents of and/or any omissions from Idx24.

The Attendee agrees that the Vendor is in no way responsible for the Attendee's actions or for the performance of Idx24 or for the behaviour of markets generally and agrees to INDEMNIFY and continue to INDEMNIFY and PROTECT the Vendor from any damages resulting from the Attendee's direct or indirect use of Idx24.

7. Disclaimer

The Attendee understands and accepts the following statement from the Vendor.

"The Vendor does not guarantee in any way that the Attendee will realize any trading profits whatsoever or that they will not incur substantial loss. No presentation is being made that any account will or is likely to achieve profits or losses similar to those attained by Brent Penfold during his 90-days of live trading."

"The information provided with Idx24 is EDUCATIONAL and IS NOT A RECOMMENDATION TO TRADE. THERE IS RISK OF LOSS IN TRADING. Historic or hypothetical or actual trading performance DO NOT INDICATE FUTURE SUCCESS. The Vendor WILL HOLD positions in the market from time to time."

8. Acknowledgement Workshop is Educational Only and Does Not Constitute Trading Advice

The Attendee acknowledges, understands and accepts the Workshop is educational only and does not constitute or contain any trading advice. The Attendee acknowledges, understands and accepts that by attending the Workshop they will receive an education into how Idx24's methodology trades global indices through nine individual strategy set-ups and the respective accompanying trade plans involving entries, stops and exits.

9. Acknowledgement 90 Days of Living Trading Does Not Constitute Trading Advice

The Attendee acknowledges, understands and accepts the 90 days of live trading does not constitute trading advice. The Attendee acknowledges, understands and accepts the 90 days of live trading is designed to reinforce their educational knowledge of how Idx24's trading methodology is applied and is not a recommendation to trade.

10. Acknowledgement of Risk of Loss in Trading

The Attendee acknowledges, understands and accepts there is risk of loss in trading and that historic, hypothetical or actual trading performances do not indicate future success.

11. Acknowledgement of the Need to Consider the Appropriateness of Idx24 before Implementation

The Attendee acknowledges and understands the information and trading ideas contained in Idx24 do not take into account their own personal investment objectives, financial situation and particular needs. The Attendee acknowledges it is their responsibility to consider, with or without the assistance of a licenced financial adviser, whether the trading ideas contained in Idx24 are appropriate, in light of their own investment objectives, financial situation and particular needs, before implementing any trading ideas.

12. Acknowledgement of No Software Being Supplied

The Attendee acknowledges, understands and accepts the Vendor will not be supplying any software designed to assist in the identification of Idx24 trading set-ups and management of trading positions.

13. Acknowledgement Not to Use Third Parties to Program Idx24

The Attendee acknowledges, understands and accepts not to engage a third party to program Idx24. The Vendor acknowledges, understands and accepts the Attendee can personally program Idx24 in their preferred software program.

14. Compensation For Breach Of Agreement

The Attendee acknowledges and agrees that due to the unique nature of Idx24 proprietary information, there can be no adequate remedy at law for any breach of its obligations hereunder. Therefore upon any such breach the Vendor shall be entitled to seek appropriate equitable relief in addition to whatever remedies it might have at law.

15. Payment by Bank Deposit

The Attendee acknowledges and agrees the appropriate payment to secure a place at the Workshop will be paid by bank deposit.

16. Acknowledgement and Agreement
